FOOD CONCESSION VENDOR INFORMATION

Thank you for your inquiry about a food concession space. We give first preference to returning concessionaires, but we welcome new opportunities. Any space not filled by returning concessionaires is available to new customers and are issued based upon what is lacking in concession variety. It is up to the fair's discretion as to whom is awarded the contract.

We would appreciate additional information on your concession to help us get to know your business better. Please fill out the enclosed concession application and return it to us, along with your menu, references and photographs of your unit. This information is important to use when selecting new concessions.

Depending upon size and location, fees are a flat rate or a percentage of gross sales excluding sales tax, whichever is the greater amount. Flat rates run \$250.00-\$5000.00. The percentage is 23%.

The State of California requires proof of commercial general liability insurance with a minimum coverage of \$1,000,000.00 per occurrence. If you do not have your own insurance, you can purchase it through the Fair from CFSA, the premium is \$125 per concession.

If applicable all concessions must have a Seller's Permit from the California State Board of Equalization.
