Commercial Vendor Fees

Concession Fees

Depending upon size and location, fees are a flat rate or a percentage of gross sales excluding sales tax, whichever is the greater amount. Flat rates run \$200.00-\$1000.00. Percentages are 18% for nonprofit organizations and 20% for commercial concessionaires.

Insurance

The State of California requires proof of commercial general liability insurance with a minimum coverage of \$1,000,000.00 per occurrence. If you do not have your own insurance, the premium is \$84 per commercial exhibitor and \$108 per concession available through the fair from California Fair Services Authority. If a contract is deemed hazardous, insurance coverage ranges from \$1,000,000.00 to \$3,000,000.00 depending on the activity. A premium quote is available from CFSA.
