**TULELAKE-BUTTE VALLEY FAIR  
MISS TULELAKE/BUTTE VALLEY COMPETITION DESCRIPTION**

**ELIGIBILITY:**

- Residency: All contestants must have RESIDED in the 10-A District at least the past 6 months.
- Age: Contestants must be Sophomores or Juniors in High School and age 16 or older.
- Other: Contestants must be single, (never married), never been a parent (never pregnant) and female. Contestant must be able to provide her own transportation at least to and from Tulelake.

**GENERAL RULES:**

- Application: All applications (pages **2 & 3** of this packet, **2 photos** to be used in the newspaper, **transcripts** of previous two years, and **2 letters of recommendation**) must be submitted to the Fair Office (by mail or in person) by **April 21, 2008**
- Process: Applications may be screened. Judging interviews & dinner will be held **April 30th at 6:00 p.m.** at Mike & Wanda’s Restaurant in Tulelake. Miss Tulelake and Miss Butte Valley will be chosen to represent the Tulelake-Butte Valley Fair at Dorris 4<sup>th</sup> of July celebration, at other fairs/parades and then act as the official hostesses of the Tulelake-Butte Valley Fair on September 3-7, 2008. “Fair Court” clothing (examples: dress, shoes, jacket, pants, shirt) will be purchased under the supervision of the Fair Court Committee, with a budget of \$200 or less per girl. Each girl will be provided with a tiara and sash. Clothing will be kept clean and in good condition by the Fair Court. Ownership will be given to the members after the Tulelake-Butte Valley Fair. Fair Court members shall at all time conduct themselves in a friendly, courteous and appropriate manner. After proof of college attendance (after at least 1 semester), a \$250 scholarship will be awarded to each Fair Court member. Miss Tulelake and Miss Butte Valley are also eligible to compete in the Miss California State Competition should they choose; however, the Tulelake-Butte Valley Fair cannot assist financially.

Social responsibility (activities: fair, community).....	25%
Academic Achievement .....	10%

**I AGREE** to permit the release of my photographs for publicity purposes in connection with this competition.

**I AGREE** to participate in the process including judging, shopping (only chaperones will attend shopping trip NO family members or friends may accompany Queens), any orientation meetings and a photo shoot. If chosen Miss Tulelake or Miss Butte Valley, I agree at all times to represent and promote the Tulelake-Butte Valley Fair in a friendly, courteous and appropriate manner. I agree to make personal appearances as required during my reign, including **4<sup>th</sup> of July** events in Dorris, several other fairs/parades, radio ads and at least 6 hours per each day of the Tulelake-Butte Valley Fair. The possible schedule is: Anderson, Susanville, Yreka, Klamath Fair, Cedarville Fair/Parade, MacArthur, and the Merrill Potato Festival. I understand that any behavior deemed inappropriate by the Fair Court Directors will result in my immediate expulsion from the Fair Court and relinquishment of eligibility for all prizes. Inappropriate behavior is defined as use of alcohol, illegal drugs, tobacco products, profanity... and any other indiscretion as determined by the Fair Court Committee (i.e. any public displace of affection). I agree to conduct myself in a respectable manner at all times while attending fair activities and will make every endeavor to punctually attend each scheduled events.

**I AGREE** to attend each scheduled fair time events (i.e. ball games, rodeo, concert, awards ceremony), dressed in fair court attire, along with only my fellow queen and chaperones and no other persons (boyfriends/girlfriends, family members)

Failure to do so will result in a zero score for that portion of competition.
